However, the above university, will not be eligible to receive any assistance from University Grants Commission and any other source funded by the Government of India till the University is declared fit to receive Central assistance under Section 12 (B) of UGC Act, 1956


With reference to your letter No. SSU/WORK/11258/05 dated 17.11.2005
